## SECOND AMENDMENT TO DECLARATION OF RESTRICTIONS OF ROLLINGBROOK SUBDIVISION SECTIONS ONE. TWO AND THREE

THIS SECOND AMENDMENT TO DECLARATION OF RESTRICTIONS TO ROLLINGBROOK SUBDIVISION - SECTIONS ONE, TWO and THREE is made this & day of Joly , 2010, by RBTM PEORIA, LLC, an Illinois limited liability company ("Developer").

## I. RECITALS

WHEREAS, RBTM PEORIA, LLC, an Illinois limited liability company, is the developer of certain real estate in Rollingbrook Subdivision - Sections One, Two and Three in Peoria County, Illinois ("Subdivision"), which is legally described in Exhibit A attached hereto and made a part hereof;

WHEREAS, the final plat of Rollingbrook – Section One, was recorded in Plat Book 9 at page 105 as Document No. 05-23321 in the Office of the Recorder of Deeds of Peoria County. and on September 1, 2005, the Declaration of Restrictions of Rollingbrook Subdivision - Section One, were recorded as Document No. 05-28811 in the Office of the Recorder of Deeds of Peoria County;

WHEREAS, Developer filed a second plat of Rollingbrook Subdivision - Section Two in Plat Book 10 at page 70 as Document No. 06-34823 in the Office of the Recorder of Deeds of Peoria County, with restrictions substantially similar to the restrictions of Rollingbrook Subdivision - Section One as Document No. 06-34824 in the Office of the Recorder of Deeds of Peoria County (including corrective Declaration of Restrictions Rollingbrook Subdivision -Section Two filed as Document No. 06-38340);

WHEREAS, Developer filed a third plat of Rollingbrook Subdivision – Section Three in Plat Book 11 at page 13 as Document No. 07-07616 in the Office of the Recorder of Deeds of Peoria County, with restrictions substantially similar to the restrictions of Rollingbrook Subdivision – Section One and Section Two recorded as Document No. 06-34824 and Document No. 06-34823, respectively, in the Office of the Recorder of Deeds of Peoria County (including corrective Declaration of Restrictions Rollingbrook Subdivision – Section Two filed as Document No. 06-38340).

WHEREAS, Developer filed First Amendment to Declaration of Restrictions of Rollingbrook Subdivision – Section One and Restatement of the Restrictions of Rollingbrook Subdivision – Section Two (Rollingbrook Subdivision Sections One, Two and Three), recorded July 24, 2007 as Document No. 07-23991, under which First Amendment Sections One, Two and Three were combined under one Declaration of Restrictions, as amended, which Declaration applies to all three sections.

WHEREAS, pursuant to Article VI, Paragraph 2, Developer retained the right to amend the Restrictions until Developer had divested itself of all interest in the lots of the Subdivision.

NOW THEREFORE, Developer hereby amends the Declaration of Restrictions of Rollingbrook Subdivision, Sections One, Two and Three as follows:

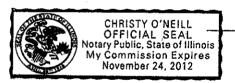
Article IV, Subparagraph 23 Fencing shall be deleted and replaced by the following:

23. Fencing. Other than a perimeter fence along Alta Road and the subdivision installed by Developer, no fences of any kind are permitted on the duplex lots. Developer has approved the following fencing types for the single family lots: black vinyl coated chain link fencing and black rod iron fencing, providing, however, that the Lots 24 through 33 in Section One of Rollingbrook Subdivision shall be allowed to use wooden fencing at the rear lines of their properties. Fencing shall not exceed a maximum height of four feet (4') except fences surrounding in-ground swimming pools which shall be the height required by City Code. No invisible fences or dog runs of any kind shall be permitted in the Subdivision. All fencing must meet these approved fencing specifications unless approved by Developer.

Except as herein amended, the Declaration of Restrictions, as Amended, shall remain in full force and effect according to its terms. To the extent that there are inconsistencies or conflicts between this Second Amendment and the Declaration, this Amendment shall control in all respects.
